Don't Want to Pay Your 2014 Homeowners Dues in 1 Lump Sum?

We CAN help...

As approved by the membership present at the Annual Meeting on December 1st, 2013, the 2014 Annual Homeowners annual dues are \$404.25. Invoices will be sent out prior to the 15th of January and will be due no later than March 31, 2014. Payments received after March 31st are subject to late fees and interest in accordance with our declaration of restrictive covenants and by-laws.

Any homeowner wanting to make an agreement for partial payments on their account prior to the March 31st deadline, will not be charged late fees or interest (even if there account is not paid in full by March 31st) IF..

- > an acceptable agreement, in writing, has been made with the Lake Camelot office
- > payments are made on time in accordance with the agreement
- > date of final payment has been stipulated in the agreement
- > member is currently in good standing with the association

To be paid on time, you can make partial payments yourself starting 01-01 to 03-31-14
Payments made weekly from January 1st through March 31st = \$31.10 a week
Bi-weekly from January 1st through March 31st = \$62.19 bi-weekly
Monthly from January 1st through March 31st = \$134.75 monthly

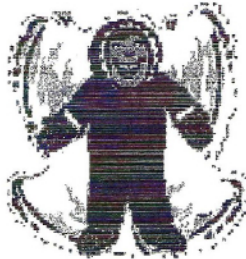

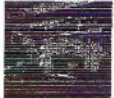

We at Logan-Trivoli Fire Protection District and the Lake Camelot Firefighters would like to wish you and your family good health and fortune in the New Year. 2014 should be a big year for the Lake Camelot Firehouse as we continue the planning phase of fire station expansion and hope to break ground in the spring. The district officers will be holding their annual winter planning retreat in a few weeks to work on our 10 year plan for the fire department. Part of that 10 year plan is the expansion of the Lake Camelot Station and a replacement fire engine for the Lake Camelot Station. We recently applied for several grants that hopefully will allow us to get much needed replacement equipment. LAND AND LAKES COMMITTEE

Minutes - Land & Lakes Committee
Wednesday, December 4, 2013

Call to Order: The meeting was called to order at 6:30. Committee members in attendance were Collin Cochran, Glenda Carlson, Steve Harenberg, Lynn Gosnell, Deb Metroff, Bernie Sieks, and Bruce Whelchel. Bruce introduced and welcomed Richard Novitsky as a new committee member. Richard is an Architect with PSA-Dewberry.

Report on the November 20th Board Meeting: Collin & Glenda gave a brief report.

Report on the December 1st Annual Meeting: Collin & Glenda gave a brief report that included the action taken on the 2014 Budget. The 10% dues increase was rejected by the membership in attendance. The members approved a 5% increase that could have an impact on funds that are allocated for erosion and dredging projects.

Dam & Bridge Inspection Reports: Discussed progress since our last committee meeting and plans for work to be completed on the following:

- 1. Work on rodent burrow control and vegetation control:** Glenda reported on the most recent inspection report completed by our maintenance staff. Everything looked good.
- 2. Upcoming dam & bridge inspection:** Glenda reported that this year's inspection will be done on Friday, December 6th. Dam inspection is done every year and bridge inspection is done every other year (scheduled for this year). Glenda reported that the inspection of the upper lake spillway will require three workers and a camera at an additional cost of \$2000.

Discussion of Plans and Progress for Completing Erosion Control Project Number 1:
The Board approved \$7,500 for this project. To date we have spent approximately \$4,500 and estimate that we might need to spend up to an additional \$1,500 to complete the project. The eroded area still needs more rock to prevent further erosion. We also need a trench to redirect water flow, in a swampy area, up-stream from the eroded area. The contractor doing the work has agreed to come back, after the ground is frozen, to dig the trench. In addition, he will remove some fallen trees once the ground is frozen. We estimate that our total cost will come in well under the amount budgeted.

Blocked outlet pipe from the roadside ditch inlet to the upstream side of the south abutment of the lower lake dam: The committee recommends that Greg add more rock to the shoreline. The committee agreed that the work needs to be done while the lake is drawn down and before Greg goes on furlough in January.

Additional Projects that Deal with Erosion Control and Siltation: Discussed progress and plans for work to be completed on the following:

- 1. Strategy for working with neighboring land owners (with the help of Scott Wallace and Gary Gorden from the USDA- NRCS) to control erosion into our lakes:** Tabled until March, 2014.
- 2. The siltation ponds at the North end of Lake Camelot and the West end of Lake Lancelot:** Only one bid has been received on these projects. Bruce has contacted additional contractors and is hoping to meet with them in the near future. The Committee agreed that it makes sense to modify the area to construct a permanent work area. This will save time and effort when dredging is done in the future.
- 3. The park access area that runs between Tewksbury and Canterbury:** Bernie reported on work he has completed. Bernie reported that drainage and stand pipes still need to be purchased for this project
- 4. Possible follow up on contact with Lake Wildwood and the methodology and equipment they used in solving their erosion and siltation problems:** Bruce was in contact with their General Manager, Joan Boyer, and reported that she will accommodate the Committee anytime. The Committee agreed that whoever was going, should do so this month. Bruce, Glenda, and Steve H. committed to going. Bruce will make arrangements and email the committee on the time; anyone is welcome to join them.

Lower Lake Boat Ramp: Bruce and Collin reviewed the *Instruction for Bids* that they used in requesting bids. When the selected contractor started work on the project, they found that the existing concrete was worse than anticipated and the whole ramp would need to be replaced. An additional \$2,000 was approved for the added work and materials, bringing the total cost to \$4403. The project should be completed by Thursday, December 5th. The cost of this project will not come out of our Erosion and Dredging Budget.

2013 & 2014 Budgeted Funds and Projects to move forward on: The committee briefly went over what has been spent on projects, as well as what still needs to be spent. The committee agreed that Bruce will get with Glenda to get exact numbers and include the up-to-date numbers in the minutes. Updated numbers are as follows:

The committee started 2013 with \$33,700 in the erosion and dredging budget. Based on the \$8403 spent and the approximate cost of the remaining work (\$500 - \$1000), the balance remaining ranges from \$24,297 to \$24,797.
The proposed budget for 2014 listed an additional \$16,000 (\$10K for erosion and \$6K for silt pond dredging). However, since the dues increase was reduced from 10% to 5%, the \$16K budgeted could be modified. The 2013 Board needs to update their 2014 budget based on reduced available funds. The committee agreed that once we know the additional budgeted funds, we will prioritize 2014 projects within our financial constraints.

Next committee meeting - February 5th The committee agreed to not meet on the first Wednesday in January - 1/1/14. However, if anything comes up, Bruce will keep the committee informed via email; or if necessary, schedule a special meeting.

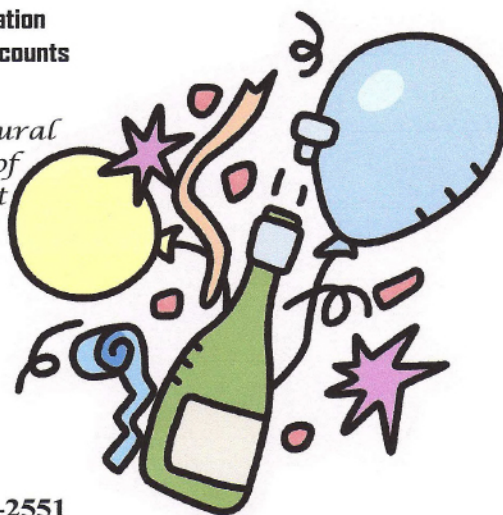

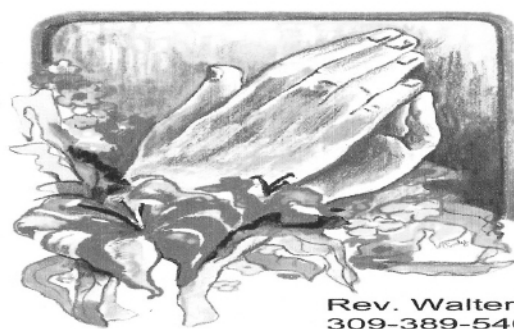
