Marina & Boating Safety

Boats can be a great source of summer fun and leisure. But, boaters, swimmers, and marina staff must be aware of dangers in and around the water. Electrical hazards and carbon monoxide (CO) bring unique risks to the boating world. Learn to protect people and pets from these dangers.

ELECTRICAL SAFETY

- Never allow swimming near the boat, marina, or launching ramp. Residual current could flow into the water from the boat or the marina's wiring. This can put anyone at risk of electrical shock drownings (ESD).
- Be sure your boat is well maintained. Have it inspected each year. Ask a qualified marine electrician to do this job.
- Ground fault circuit interrupters (GFCIs) and equipment leakage circuit interrupters (ELCIs) should be installed and tested monthly. Run tests to find out if electrical current is leaking from the boat.
- Only use cords intended for marine use. Never use household cords near water.
- Know where your main breakers are on both the boat and the shore power source. This will help you respond quickly in an emergency.

CARBON MONOXIDE SAFETY

- Poorly tuned engines produce more CO. Keep your engine properly maintained. Follow manufacturer's instructions for service.
- Proper ventilation for engine and generator exhaust vents must be clear and pipes should be inspected for leaks.
- Get into fresh air right away and get help if you feel symptoms of CO poisoning. These include headache, fatigue, confusion, dizziness, nausea, or seizures. The symptoms can be similar to seasickness. Assume it is CO exposure until you are sure the boat is safe.
- Do not swim near the boat's exhaust vents. CO accumulates there.
- Install CO alarms inside your boat. Test CO alarms before each trip.
- Choose a CO alarm that is listed by a qualified testing laboratory.
- If the CO alarm sounds, move to a fresh air location right away.

KNOW THE RISKS!

Electrical shock drownings can occur when marina electrical systems leak electrical current into the water. Boats can also serve as the source of an electrical leakage. Leakage can cause a shock that can injure, disable, or kill a person.

Carbon Monoxide is a gas you cannot see, taste, or smell. It is often called the "invisible killer." CO is created when fuels such as gasoline, diesel, or propane do not burn fully. CO is also produced when wood or charcoal is burned.

Sources of CO on your boat may include engines, gas generators, and cooking ranges. Space and water heaters can also be sources of CO. CO can collect anywhere in or around a boat. The gas is harmful to both people and to pets.

FACT

CO can remain in or around your boat at unsafe levels even if the engine has been turned off.

Violators will receive a \$50.00 fine for failure to comply.

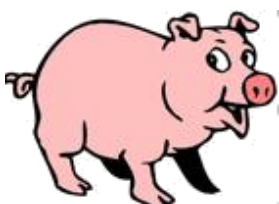

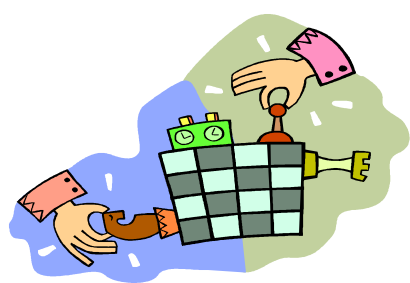

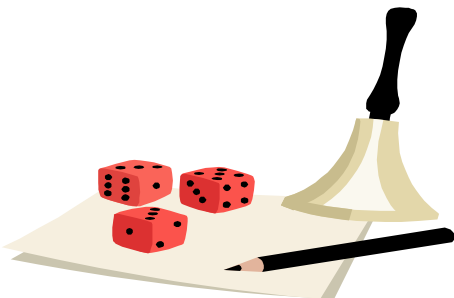

INFRASTRUCTURE/LONG RANGE PLANNING COMMITTEE (ILRPC)

Minutes – Infrastructure/Long-Range Planning Committee (ILRPC)

Tuesday, July 11, 2017

Call to Order - The meeting was called to order at 5:00 PM. Committee members in attendance were Jim Sinclair, Kevin Arduini, and Suzanne Wheeler. Board Liaison Carol Benson attended. Jeff Lox and Roger Markle were not able to attend. Guests attending: None.

Report on the June 2017 RTA Meeting – The Board a) approved paying the costs of the Sir Tristran culvert repair; b) gave the okay to have a quote obtained for the Canterbury culvert project; and c) liked the idea to research the rest of the community drainage and prioritize the needs. I told the Board that the committee would not support any more fence painting and recommended they get a refund on the unused paint and supplies.

Culverts – Jim told the committee the Board obtained a quote from FCI Excavation for the Canterbury issue for \$600. The Board approved this work via email and the work was completed on July5th. Kevin indicated that he talked to Gary Guengerich the night of July 10th storm. Gary said that most of the problem was resolved (the upper part of his property); however, there is still a little work to be done on the lower part of his property. We need to re-look at the work done and see if adjustments could be made to help the flow of water through the wire rock baskets installed 5 years ago. It appeared that rock and dirt has accumulated there over the years.

Over the next few months, the committee will focus on the community’s water drainage system as follows:

- Contact the township road commissioners to determine a) if we could get copies of any maps showing the original community drainage system; b) their understanding of responsibility (township, Camelot RTA, and/or the member) to maintain the various components of this system; and c) what assistance is available to upgrade/replace any part of this system from the township or other governmental sources.
- Confirm (assuming maps are received or we will make larger copies of the telephone directory map) or determine where the culverts diverting water away from the roadway are located, where they go, and begin making notes of observable issues like the two described in last month’s minutes on Whittingham. Additional discussion with members would occur to gain a full understanding. This would include driving through the streets during a rain storm to identify dangerous situations.
- Contact Land & Lakes committee to determine which ravines are impacted and how a solution would fit into the anticipated ravine work.
- Create a list of potential areas needing emphasis, discuss with appropriate township road commissioner and member(s) affected, obtain estimates if RTA and/or member responsibility, and make recommendations to the Board for repairs in coordination with Land & Lakes ravine needs.
- Educate the members with the facts obtained above.

Club House ADA Analysis – Jim gave the committee a copy of the Illinois Accessibility Code Site Inspection Checklist to begin discussing. We know that the bathrooms and the ramp to the main floor do not comply with the codes. We will determined what, if anything, we are required to change as a “private” community. We would ask the Board’s guidance on the following:

- Focus on the main floor, basement, or both floors;
- Create a plan over several years to bring us into ADA compliance; and
- Specify an area or areas that need to be addressed first.

We welcome members to attend the monthly meetings to gain knowledge and volunteer their expertise to help us analyze the entire complex.

Committee Projects – No Project Request Forms were presented by the community this month.

Other possible item for 2017 consideration – Parking lots, tennis courts surface, club house deck sealing, digital signage at entrances.

A Closer Look: Algae Blooms

Algae usually respond first when excess nutrients are added to a lake due to their position at the base of the ecosystem. When an algae bloom occurs, you can sometimes sense a difference in the lake water if it becomes murky, turns a greenish color, or has an unpleasant smell. Once the overabundance of algae starts dying off and decomposing, the dissolved oxygen concentration in the water decreases and other organisms in your lake like fish have a difficult time surviving, causing even more problems in the ecosystem.

Once algae blooms occur, it is difficult to control them. This is yet another reason it’s best to avoid adding extra nutrients to your lake in any form. Small steps that you can take include avoiding using fertilizers on your lawn, maintaining a natural shoreline, and ensuring that your septic system is leak-free. These efforts will make a big difference in keeping your lake healthy and happy for years to come.

Finance Report: The Treasurer, Leah Allison, reported the financial report from June 2017 to the Board and members present. The financial report was approved as presented.

President Harenberg thanked all the members for coming.

COMMITTEE REPORTS

Infrastructure/Long Range Planning: In the absence of Jim Sinclair, the ILRPC report was given by committee board liaison, Carol Benson-O’Connor. She reported on the problems with some culverts in the community that need to be worked on. FCI Excavation has worked on 2 of them. They are also working to make a map for drains in township, also on an updated Clubhouse ADA Analysis- See additional information in ILRPC July Meeting Minutes.

Land and Lakes: John Hecker reported with Steve Harenberg about the work needed on a couple of the ravines. Ravine #5 will be addressed as weather allows. Ravine #9 is working and doing the job for which it was designed, so they are hoping to move forward with more. Bruce Whelchel is developing an Emergency Action Plan for the dam, as is required by the State of Illinois.

Health and Environment: Bill Krokos is the board liaison for this committee and is seeking two additional committee members. He is also seeking a chairperson for the committee and another member that is also on the leech lines. If interested, please contact the office or Mr. Krokos.

Fundraising Committee: Vickie Mulligan reported on the committee meeting held on June 29, 2017. The Quarter Auction has been moved to November 4, 2017. Bags Tournament & Potluck Dinner has been discussed. More information to the membership will be forthcoming.

Security Report: Michele Smith reported that 5 fines and 2 violation warnings for boat violations have been issued in the last 2 weeks. Discussion was held on the fine structure for boating violations. The Board deferred discussion on this topic for later in the meeting. Michelle further reported on juvenile infractions on RTA property, which are currently subsiding due to increased security. Donald Brandenburg was introduced as a new member of the security team for the 2017 season.

CLUB REPORTS

Activities Club: Board Liaison Cathy Doss reported that the Committee raised \$1,300.00 from the 5k run. The 4th of July didn’t break even after Board contribution, but it should help when the candy leftover from the event is sold. 319 Grant Application The General Manager reported that work on the 319 Grant Application continues with Cathy Molchin, Lake Camelot volunteer, and Peter Berrini & Associates. Bill Krokos expressed his sincere gratitude for all their hard work and the countless hours put in to getting the application ready in hopes we can receive some grant money for ravine repairs.

Ameren/Advanced Metering Installation Project: Installation have been completed.

Ravine #5 Progress Report: Will be burned or buried week of July 29, 2017.

4th of July Festivities Report: Association activity expense reported through June is \$3,150 with \$7,500 having been budgeted for 2017. A new fireworks contract has been sought for the next three years at the same annual price of \$4,000.00 with J&M Fireworks.

New Swimming Pool/Engineer/ Cost/ Finance Options: Mr. George Kelly of GKP has been hired to design a new pool for Lake Camelot. He is in the process of getting costs estimated based on the basic design of our current pool with some minor changes and costs for possible additions such as fountains, slides, etc. He hopes to have the information to the Board by the end of the week, July 21st. 3 drawings will be done for the Board to review and the estimated costs for every drawing.

NEW BUSINESS

9th Annual Pig Roast for 2017: Will be held Sept. 16, 2017. Tickets will be for sale in the office or from Melissa (Alwood) Edwards.

CAMELOT ROUND TABLE ASSOCIATION
SPECIAL MEETING OF THE BOARD MINUTES
JULY 15, 2017 (UNAPPROVED)

Call to Order - President Steve Harenberg called the Special Meeting of the Board to order at 9:10 a.m. Members present were Bill Krokos, Leah Allison, Cathy Doss, Scott Perkins, Vickie Mulligan, John Hecker, and Carol Benson O’Connor. Absent was Bob Wilder. Also present was Glenda Carlson, Acting General Manager.

This was the initial meeting with Architect, Mr. George Kelly, Architect, whom has been contracted by Camelot Round Table Association, Inc for the development, preparation of construction documents, preliminary & design plans and elevations for a new swimming pool.

Mr. Kelly came to the meeting with pictures of other pools he has designed and been involved in with new installations at both Lake Wildwood in Varna, IL and the Tremont Pool. He discussed several applications of additions chosen by those entities and provided the Board with ideas and / or possible recommendations for the Lake Camelot pool such as a slide, water sprayer in kiddie area, deck lighting, heater for the pool, etc.

The Board is in agreement that the pool will remain in the same location as the current pool but that the layout may be changed to take the deep end away from the back side of the hill, combine the wading pool with the intermediate pool and have a zero lot line entry, and providing a shaded area with the use of big (ger) commercial umbrellas. Discussion was held on competition swim lanes and depth requirements for same. The Board was not unanimous in agreement as to whether to build a pool with competition swim lanes so asked Mr. Kelly to provide a cost estimate with and without the additional footage and width required to have a competition pool.

Mr. Kelly stated he will provide the Board a cost estimate for the basic pool package as is currently designed, then allow for some of the construction changes in the build and cost those along with also then providing costs estimates for those items that would be placed on the wish list to be chosen if funds allowed. He hopes to have this information to the board in the next couple of weeks.

The Board will then have an opportunity to review the documents and estimated costs, vote on the preliminary design, return the information to Mr. Kelly for an initial draft of the new pool.

Adjournment: Leah Allison made a motion to adjourn the meeting at 10:40 a.m., seconded by Scott Perkins. All in favor, motion carried.

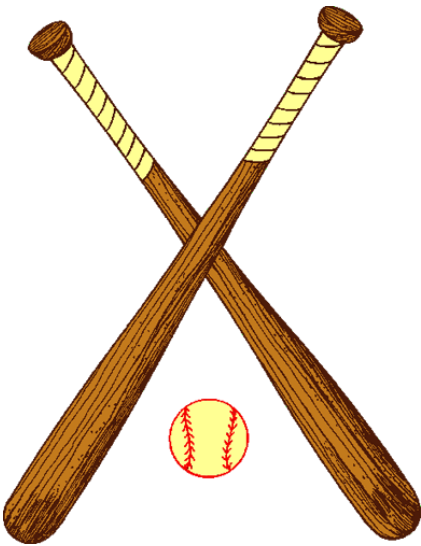


