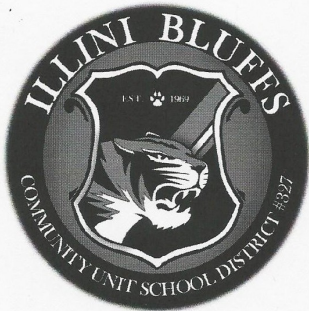


ILLINI BLUFFS CUSD #327 REVEALS NEW LOGO

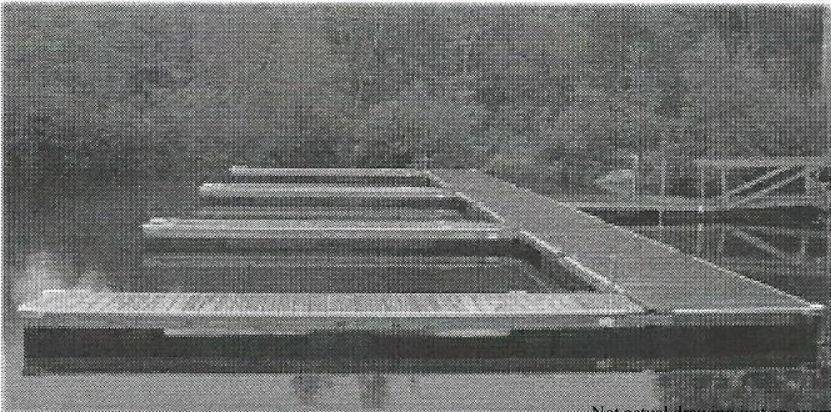





BOARD MEETING MINUTES (UNAPPROVED)

January 21, 2015

Call to Order –President Steve Harenberg called the meeting to order at 6:30p.m. Board Members in attendance were Gary Smith, Cody Martzluf, Cathy Doss, Bill Krokos, Leah Allison, Brian Woertz, Scott Wright and Matt Buczynski. Also present was Glenda Carlson, General Manager.

Approval of Minutes – Cathy Doss read five (5) corrections to the meeting minutes. 1. Bernie Sieks, Lot 665 should be recognized as a member in attendance at the December 17, 2014 meeting. 2. The Board of Directors received and accepted a resignation letter from Max Bryant, Lot 402 effective immediately from the E.C.C. along with Mike Haffner, Lot 616, stating due to time constraints he too would need to leave the committee but would remain until a replacement could be found. The Board thanked both of them for their service and will look to appoint two new members to the E.C.C. 3. President Steve Harenberg recommended the Board approve a monetary gift be given to Sabrina Petesch for all her work with the Covenant Review Committee on the 2015 revision of the Declarations and By-Laws. Sabrina thanked them for the offer but graciously declined the gift. The Board and community would like to thank Sabrina for all of her time and offering of services. 4. Member Patti Underwood reminded the Board to be sure that our newly revised Declarations and By-Laws be inc compliance with the provisions within the Illinois Condominium Property Act. Sabrina stated she would check the document before it goes to be recorded. 5. Bill Krokos abstained from voting on choosing an attorney for Lake Camelot for legal representation since he did not have adequate time to review the choices given. Leah Allison made a motion to approve the December 17, 2014 meeting minutes with the above stated corrections. Motion was seconded by Scott Wright, motion carried.

Finance Report – Treasurer Leah Allison presented the Finance Report for December 2014. Leah discussed the money left over from the pool operating budget and the snack bar is because of the cool weather that we had and asked the Board to approve \$10,000.00 to go in the pool reserve account and hold onto \$1264.16 for the valve problem on the upper lake water cement tank. Cathy Doss made a motion to transfer the funds to a capital reserve account for Swimming Pool Improvements and accept the Finance Report as presented, Gary Smith, seconded. All in Favor, Motion carried.

Recognition of Members and Guests – In attendance was Brian Emhoff, Lot 795; Collin Cochran, Lot 686; Sherry Waters, Lot 531; John Hecker, Lot 350; Don Thompson, Lot 405; and Ben Massey, Lot 913-914.

Committee Reports

Infrastructure – Matt Buczynski reported that his committee is working on the long-range planning process projects, e.g., parking lot and boat dock sealing, a 30 year long term planning report. Matt asked the Board to approve Kevin Arduini to their committee, the Board approved.

Land and Lakes –.Steve Harenberg asked Collin Cochran to report on behalf of the committee. Collin reported that he and Bruce Whelchel were working on the problem on the upper lake water valve. They were checking with Illinois American Water Company. Their next meeting will be held on Tuesday, February 3, 2015 instead of the first Wednesday and he asked it so be noted in the February Newsletter. They did not have a meeting in January.

Health and Environment – Gary Smith -NO REPORT.

Security Report – Brian Emhoff had submitted a written report to the board. Nothing further to report.

Club Reports

Activities Club- Cathy Doss reported that the Activities Club discussed the low turnout for the Santa Breakfast and things they could change for a better turnout. Trivia Night is April 24th to benefit Janet Huene and her family. Other events are March 11th at 6:00 p.m. stuffing Easter eggs; March 13th movie night; March 28th Easter Egg Hunt; August 21st will be Trivia Night and October 24th will be the pumpkin decorating and Halloween Costume Party. Election of Officers for 2015 is the following” Co-Presidents, Kristy Bushart and Angie Robertson, Secretary, Angie O’Connor and Treasurer, Greg Petesch.

Sportsman’s Club - Collin Cochran reported that the Ice Tournament will be dependent on the weather and the thickness of the ice. The Club will buy tackle from Collin Cochran at h is cost for the Ice Fishing tournament., Collin will be submitting application for the placement of signs for both the tournament and the Tackle Swap in February. He reported twelve tables have been spoken for at the Tackle Swap. The Sportsman’s Club will hold their next meeting Thursday, January 22, 2015 to discuss further.

ECC Reports - **The General Manager reported two nominations had been received for appointment to the ECC Committee.** Gary Smith made a motion to accept John Hecker and Bruce Whelchel as the new E.C.C. members. Matt Buczynski seconded. Motion carried. Matt Buczynski made a motion to accept the E.C.C. recommendation and Gary Smith seconded. Motion carried.

TABLED ITEMS-Reserve Replacement Study - Still in Progress;
Foth Dam Inspection Report 2014-Not yet Received

OLD BUSINESS

COVENANT/FILING OF DOCUMENTS - The General Manager reported that Sabrina Petesch had completed her review of the draft that has been prepared for the filing of the approved documents at the Courthouse with some clarification needed on some of the verbiage that had been approved by the Board of Directors. Copies of the draft was given to each Board Member for their review. Matt Buczynski made a motion to change the time for water skiing on Lake Lancelot to read from 10:00 a.m. to Sunset. Bill Krokos seconded the motion. Call for the vote - Four (4) Yeas, Five (5) Nays. Motion did not pass. After further discussion, Bill Krokos made a motion to change the time to read from 10:00 a.m. to 8:00 p.m., Matt Buczynski seconded. All in favor, motion carried.

IL American Water/Testing -Illinois American Water continues to test the water weekly and is still considering bypassing the water tower. Information regarding any decisions will not effect us financially and may increase water pressure to our residents.

Legal Representation-Contract - President Harenberg executed the contract with Brian Mooty’s office for the 2015 operating year that was approved at the last meeting.

Red Cross Blood Drive - The General Manager reported 28 possible donors attended the winter blood drive. The Red Cross appreciated the turnout and we would like to thank Lake Camelot community members that continue to give. The next blood drive at Lake Camelot will be in July

NEW BUSINESS

2015 ILMA CONFERENCE - The 30th Annual Lake Management Conference is being held this year in DeKalb, IL at NIU the 19th-21st of February. The General Manager and Maintenance Supervisor will be attending. This year Lake Camelot is the lake community to have been chosen to have their photograph placed on the conference brochures and on the ILMA Webpage. The photograph was taken by Kara Sylester. Thank you, Kara!

Fundraising/Membership Opportunities - Discussion was held on various type of fundraising opportunities that members could possibly come up with to financially benefit the community. Scott Wright suggested a community bags tournament . The Board suggested looking into how much interest there would be and asks anyone whom is to contact the office and leave your name and phone number. If enough interested in generated further plans will be ensued. Board stated that any member with any new ideas should formulate them and propose them to the board for approval.

July 4th Festivities - The General Manager reported the fourth of July fireworks cannot be displayed on the fourth due to the company not having a shooter for our area on that day. All contracts specified for the fourth of July (no matter what day it falls on) takes precedence and all 600 shooters have been contracted out. They have shooters available for us on the 3rd or on the 5th. Management further reported they checked with other display companies and either they do not shoot shows for less than \$20,000 or \$30,000 or they have already been booked for a year in advance. They too are having trouble getting shooters to fulfill all their shows. After much discussion, Gary Smith made a motion, seconded by Matt Buczynski to hold the fireworks display on Friday, July 3rd at dusk, have the 4th of July festivities on Saturday, July 4th and the band will play in the evening from 7:00 p.m. to 11:00 p.m. All in favor, motion carried. In doing so, a contract was approved to be executed on behalf of the association for the 2016 show to be shot on Saturday, July 1st and then 2017 on Saturday, July 2nd.

BOAT SLIP PROPOSAL -Brian Woertz resubmitted a proposal for the installation of boat slips (possibly 6-10) on the lower lake near the beach by the cove for the board to review and asked permission to place an article in the February newsletter asking for membership interest in having one of the boat slips for themselves. Board agreed for submission in the February newsletter.

CAMELOT RTA PROPOSAL & FUNDING FORM-Bill Krokos presented an example form he uses in his business which could be used here when presenting proposed expenditures to the Board that need to be approved. This will specify the Why, the When, and the Where monies would be spent. The Board reviewed the form and asked management to execute its use on all future proposals.

The Board went into Executive Session at 8:33 p.m. Motion was made by Matt Buczynski, seconded by Leah Allison. All in favor, motion carried. The Board came out of Executive Session at 9:23 p.m. with a motion by Matt Buczynski, seconded by Cody Martzluf. All in favor, motion carried.

ACTION ITEMS RESULTING FROM EXECUTIVE SESSION

Cody Martzluf made a motion to direct the General Manager to seek administrative privileges of the ‘unofficial’ Facebook Group titled “Lake Camelot-Round Table Association”, and to give management the discretion to develop a policy and disclaimer that allows the association to operate the group as a positive and informative communication for our community. Matt Buczyncki seconded. All in favor, motion carried.

ADJOURNMENT - Brian Woertz made a motion, seconded by Cody Martzluf to adjourn the meeting at 9:45 p.m.

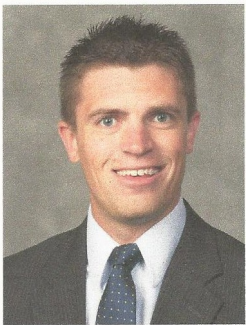
