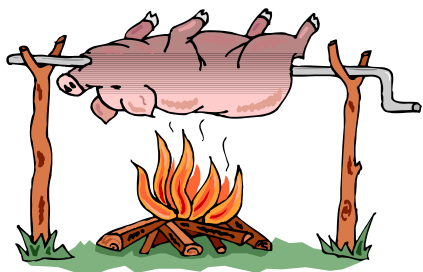

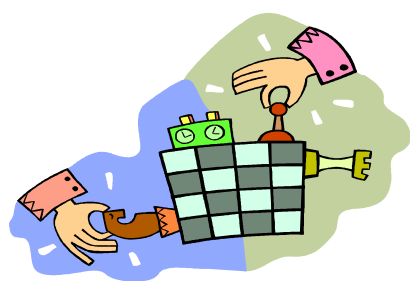

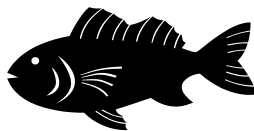

LAKE CAMELOT FIRE STATION ADDITION



Logan-Trivoli Fire Protection District is pleased to announce that construction will soon begin on an addition to the fire station in Lake Camelot. Construction on the 54’ by 38’ addition will begin in late August and will be substantially complete by December 15, 2015. The \$395,774 contract with Bishop Brothers was signed by the board of trustees at their meeting on July 23, 2015. The new addition will allow for a meeting room that will be used for fire and emergency medical service training, updated restrooms, a small kitchen, and a radio communications room. The existing fire station was built in 1990 and was too small to hold both fire apparatus and provide a location for Fire/EMS training. The Lake Camelot Station is home to six firefighters and EMS personnel. The Fire District has two other fire stations, one in Hanna City and the other in Trivoli. Fire/EMS personnel responded to over 400 calls for service last year. If you are interested in becoming a volunteer for fire department as a firefighter or medical responder, visit our website at www.logan.trovli.com and print out an application.

More personnel are needed at the Lake Camelot Station.

AUGUST 20, 2015

Approval of Minutes – Bill Krokos made a motion to accept the July 15th, 2015 minutes. Bo Pratt seconded the motion. All in favor, motion carried.
Finance Report – Leah Allison, Treasurer, reported the financial statement for July to the Board and Members. The Finance Report was approved as presented.
Recognition of Members and Guests – In attendance was Jim Sinclair, Lot 477; Donald Thomson, Lot 405; John Hecker, Lot 350; Jake Gelhausen, Lot 367, Alan Wileman, Lot 110; Roger Raydon, Lot 342, Eric Stark, Lot 572 and Dave Sule, Lot 428.

COMMITTEE REPORTS

Infrastructure – Jim Sinclair went over the projects his committee is currently working on and included information contained within the their minutes.. Please read their report contained within this newsletter

Land and Lakes – Steve Harenberg reported on the committee goals and the erosion control projects for 2014/2015. They are also working on the Bridge and Dam Report for needed temporary repair bid costs to present to the Board. These should be available soon. Please read their report in this paper.

Health and Environment – NO REPORT

Dredging Committee- Bill Krokos reported on his committee’s meeting held July and submitted a list of community members in good standing eligible and willing to serve on this committee. Brian Woertz made a motion to accept all of the said members to committee, seconded by Leah Allison All in Favor, Motion Carried. A list of those members can be found in the Board & Committee Directory within this newsletter. An additional request was made (by Bill Krokos) to add, as other communities have done, a member of the dredging committee to be an additional administrator on the Camelot WebPage where a discussion page would set up throughout the dredging process where members could ask questions, get information and be updated on progress of findings, answers to question, work in process, etc.. The Dredging Committee has asked the Board to approve Jake Gelhausen the Committee Liasion for administration on the WebPage. Gary Smith made a motion to approve the appointment of Mr. Gelhausen as the Committee Liasion for administration of association business regarding dredging on the CamelotRTA.org WebPage, seconded by Brian Woertz. All in Favor, Motion Carried. Bill Krokos then explained to the need for core samples (three from each lake) to be sent to the lab to determine types of sediment materials found in our lakes. This will help determine how we will remove them and where we may be able to put them. After much discussion, a motion was made by Matt Buczynski , seconded by Brian Woertz to proceed with the core sampling at a cost not--to-exceed \$3,000. All in Favor, Motion Carried. The next meeting will be August 27th at 6:00 p.m in the Lake Camelot Clubhouse, open the first 1/2 hour to all members in good standing. Minutes - Land & Lakes Committee

Wednesday, August 5, 2015

Call to Order: Meeting was called to order at 6:30. In attendance were Glen DeLorme, John Hecker, Bernie Sieks, and Bruce Wheelchel. Dave Sule was also in attendance.

Report on the July Board Meeting: The committee briefly discussed the minutes from the meeting that were published in the Camelot News.

Erosion Control Project for 2014 - the West End of Lake Lancelot: The committee reviewed progress since the last committee meeting and discussed the following:

1) Bruce reported on the repair work that was done to the land bridge. The heavy rains were devastating and nearly destroyed the bridge. He reported that the owners of X-Waste donated the use of a heavy duty skid-steer to do the repair work. Steve Harenberg and Kurt McBeath did the repair work. The committee thanks X-Waste (Deb Metroff and Kurt McBeath) for their donation of time, effort, fuel, and equipment. The committee also thanks Steve for all his time and effort. The committee also discussed additional work that might need to be done on the bridge.

2) The committee also agreed that the contractor needs to meet his obligations and complete the project by early September. It was reported that Glenda supplied Steve and Bruce with copies of the contract and that work to be completed includes shaping, grading, and seeding. The committee asked Bruce and Steve to contact the contractor to discuss the remaining work on the project and the timetable for completion.

Develop Plans for 2015 and a 30 Year Plan for Erosion Control: The committee discussed our revised plan to work on prioritized erosion problem areas. The Committee agreed to continue working at the west end of Lake Lancelot. These areas listed on the Plan as 11, 12, 13, & 14 will be the committee’s initial focus. The committee asked Bruce to contact contractors to get bids on the projects. Bruce reported that he obtained a list of USDA approved contractors for future projects and that he is in touch with two of the contractors and should have bids by our next meeting. The committee will also continue to reassess the previously prioritized areas and any additional areas that we need to consider. In addition to analyzing the *Hydrographic and Sediment Survey*, they will try to look at areas that appear to need attention.

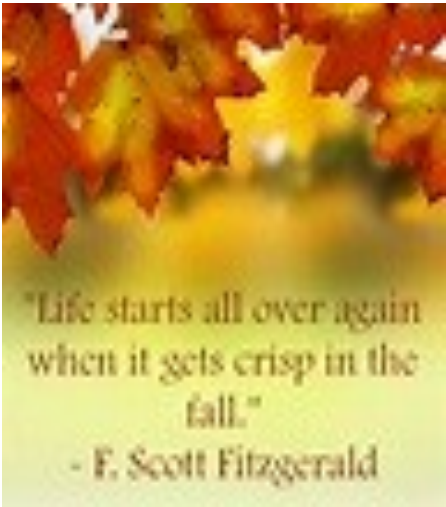

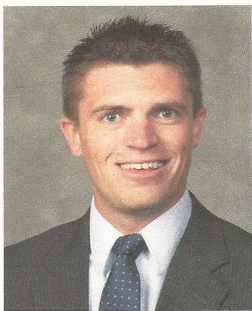

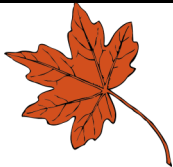
