- I. Recognition of a Quorum
 - a. DeCesari, Schoettmer, Millinger, Hegenbarth, Jones, Robertson, Lano present. Miller and Howard absent.
- II. Approval of Minutes – April 16th, 2025, and April 9th, 2025
 - a. Motion by DeCesari to approve minutes. Second Robertson. Motion carried.
- III. Recognition of Members and Guests
- IV. Finance Report – Schoettmer
 - a. Motion by Millinger to have the pool repairs discussed via email come out of Reserve account. Second DeCesari. Motion carried.
 - b. \$604,691.37 in Operating account and \$152,566.01 in Reserve Account. Finance meeting scheduled for June 9th and 6:00 p.m.
- V. General Manager Report – Rice
 - a. All Weather Courts came out to warranty repair the Pickleball Courts on 5/17/25. 3 places had paint peeling, the cracks present are not warrantied as they are normal for concrete courts and due to the expansion joints. Representative stated we should budget approximately \$20,000 to have courts resurfaced in about 5 years.
 - b. Champaign Pools are set to complete pool repairs.
 - c. Pool and Beach are set to open 5/24/25.
 - d. We received two buoy placement complaints for review.

 - i. Club to award 6 senior students with \$100 scholarships. Names tbd by IB Staff on merit.
 - ii. Club volunteers were able to repair and replace worn boards on the upper boat ramp – spearheaded by Ryan Millinger and Darrin Davis. Big thank you to them and all of the club members that helped.
 - iii. Club will present Mendenhall award at the 4th of July celebration.
 - iv. Fish fry supporting the IB Bass team was Saturday, 5/3 and was a big success.
 - c. Dog Park Club – Haffner
 - i. Club had a successful garage sale and did \$1,800 in sales.
 - ii. They are contemplating doing another Lake Camelot Gear fundraiser.
 - iii. Reviewed proposed rules and plans with the Board.
 - iv. Motion by Millinger to approve the building plans for the Dog Park pending our insurance’s approval. Second Schoettmer. Motion carried.
