CAMELOT CLUBHOUSE RENTAL AGREEMENT

- 1. Rental of the Camelot Clubhouse will be limited to members in good standing only. The renting member will be the Responsible Party for any damage/loss of RTA property or belongings. Members must be present for the entire event.
- 2. Our security deposit is \$150, accepted in the form of a check only. The security deposit is required to book your date.
- 3. The full rental fee (depends upon party size) is due no later than two weeks prior to your event. Failure to pay in full two weeks prior to your event date will result in forfeiture of your booking.
- 4. We reserve the right to deposit the \$150 security deposit check under the following criteria:
 - a. Your event exceeded the before agreed upon size
 - b. Significant damage occurred during the event
 - c. Clubhouse rental key is not returned
 - d. Clubhouse requires significant cleaning after the event
- 5. If alcoholic beverages are being served, we must have proof of liability insurance prior to your event.
- 6. Setup for your event may not begin before 10:00 a.m., and the Clubhouse must be vacated by 12:00 midnight (unless arrangements have been made with General Manager beforehand).
- 7. The Clubhouse is to be restored to the condition the renter found it in at the end of their event.
